Sharjeel Imam, 10 others discharged

NEW DELHI, FEBRUARY 4

court here on Saturday discharged 11 people including student activists Sharjeel Imam and Asif Iqbal Tanha, who participated in anti-CAA protests, in the 2019 Jamia Nagar violence case, saying they were made "scapegoats" by police and that dissent has to be encouraged, not stifled.

Noting that the accused were merely present at the protest site and there was no incriminating evidence against them, the court said dissent is an extension of the fundamental right to freedom of speech and expression, subject to reasonable restrictions.

It said investigative agencies need to discern the difference between dissent, which has to be given space, and insurrection that should be quelled.

The court, however, ordered the framing of charges against one of the accused, Mohammad Ilyas.

"Marshalling the facts as brought forth from a perusal of the charge sheet and three supplementary charge sheets, this court cannot but arrive at the conclusion that the police were unable to apprehend the actual perpetrators behind the commission of the offence, but surely managed to rope the persons herein as scapegoats," Additional

Sessions Judge Arul Varma said.

The court faulted the police for failing to produce any WhatsApp chats, SMS or other proof of the accused interacting with each other and criticised it for "arbitrarily" choosing to array some people from the crowd as accused and police witnesses, saying this "cherrypicking" by the police is detrimental to the precept of fairness.

An FIR was lodged in connection with the violence that erupted after a clash between police and people protesting against the Citizenship (Amendment) Act (CAA) in the Jamia Nagar area here in December 2019.

Imam was accused of instigating the riots by delivering a provocative speech



at the Jamia Milia University on December 13, 2019.

He will continue to remain in jail as he is an accused in the larger conspiracy case of the 2020 northeast Delhi riots.

"However, the moot question remains -- whether the accused persons herein were even prima facie complicit in taking part in that mayhem? The answer is an unequivocal no," he added.

"Furthermore, such police action is detrimental to the liberty of citizens who choose to exercise their fundamental right to peacefully assemble and protest. The liberty of the protesting citizens should not have been lightly interfered with," it said.

The court said dissent is an extension of the fundamental right to freedom of speech and expression, subject to reasonable restrictions.

It said, "It is apparent that the police have arbitrarily chosen to array some people from the crowd as accused, and others from the same crowd, as police witnesses. This cherry-picking by the police is detrimental to the precept of fairness".

The court said photographs of Ilyas showed him hurling a burning tyre and that he was duly identified by police witnesses.

"Therefore, charges levelled in the charge sheet be framed...(against) accused Mohammad Ilyas," the judge said

The court said the accused were merely present at the spot and there was no incriminating evidence against them.

"No overt act or participation in the commission of offences was attributed to them. There are no eyewitnesses who could substantiate the version of the police that the accused persons were in any way involved in the commission of the offences," the court said.

Quashing the charge of conspiracy, the court said the prosecution did not submit any proof that there was an agreement or conspiracy between the accused.

Supreme **Court gets** five new judges

NEW DELHI. FEBRUARY 4

Nive judges were appointed to the Supreme Court on Saturday with the Centre clearing the names recommended by the Collegium on December 13 last year.

Law Minister Kiren Rijiju tweeted to announce the appointment of Justice Pankaj Mithal, Chief Justice, Rajasthan High Court; Justice Sanjay Karol, Chief Justice, Patna High Court; Justice P V Sanjay Kumar, Chief Justice, Manipur High Court; Justice Ahsanuddin Amanullah of Patna High Court; and Justice Manoj Misra of Allahabad High Court as apex court judges.

Once they take oath early next week, the strength of the apex court will go up to 32 judges.

At present the top court is functioning with 27 judges, including the Chief Justice of India. Its sanctioned strength, including the CJI, is 34.

Their appointments come amidst strong observations by a Supreme Court bench questioning the delay on part of the government in appointing and transferring judges based on the recommendations of the SC Collegium.

A senior government functionary said the five appointments have nothing to do with the bench's observation and were made after the Cente took a considered decision.

The appointments came in due course, he added. PTI

The Aam Aadmi Party had before last year's Assembly polls given a "guarantee" to people that the education system will be completely transformed in the state, Mann said.

there. At Principals Academy in Singapore, they will learn the latest techniques in the education sector," the chief minister told reporters.

The first batch will return on February 11 and they will share their experience

with their colleagues, he said. Mann said the way the Delhi government have been transformed by the Arvind Kejriwal dispensation, Punjab will witness the same transformative process.

"We have talented teachers. But there was a need to update them (about the latest teaching techniques), the process for which has started today," the chief minister said, adding that health and education sectors have been the priority of his government from the very first day.

"We will send teachers to Finland as well. We will send teachers to places wherever new and latest ways of teaching are available to learn. We will also raise an outlay for education in the upcoming state budget," he said. **PTI**

Warring urges CM to consider Sidhu's release from jail

Punjab Congress chief Amrinder Singh Raja Warring on Saturday appealed to Chief Minister Bhagwant Mann to consider early release of Navjot Singh Sidhu who is serving an year-long sentence in Patiala central prison in a 1988 road rage death case.

The appeal comes a day after the Punjab Cabinet approved a proposal of granting special remission to five convicts serving terms in jails. However, the name of Sidhu does not figure in the list.

"I appeal to Chief Minister @ BhagwantMann Sahab to consider the early release of senior @INCIndia leader @sherryontopp Navjot Singh Sidhu Ji also. Matters of justice should be treated above the partisan divide," Warring tweeted.

There had been speculations that Sidhu might be granted special remission on the Republic Day.

Several Punjab Congress leaders, including former Punjab Congress chief

Shamsher Singh Dullo, had last month lambasted the AAP government for not releasing Sidhu.

On May 20 last year, Sidhu, the former Punjab Congress chief, was jailed following his surrender before a court in Patiala after he was sentenced to one-year rigorous imprisonment by the Supreme Court.

The top court had, in its order, said any sympathy in imposing an inadequate sentence would do more harm to the justice system and undermine the public confidence in the efficacy of law.

Though the court had in May 2018 held Sidhu guilty of "voluntarily causing hurt" to the man, it had spared him a jail term and imposed on him a fine of Rs 1,000.

The Punjab Cabinet on Friday gave approval for sending the case of special remission to convicts confined in jails of Punjab in the second phase to commemorate the 75th Independence Day of the country being celebrated as 'Azadi ka Amrit Mahotsav'.

ED recovers arms, contraband during raids

NEW DELHI, FEBRUARY 4

A rms, ammunition and suspected narcotics weighing about 16 kgs was recovered after raids were conducted in Punjab as part of a money laundering probe linked to a drug trafficking case, the Enforcement Directorate said on Saturday.

The searches were conducted on Friday at 10 different premises in villages like Sheron, Naushera Pannuan and Bugha in the Tarn Taran district. The business and residential premises of Skattar Singh alias Laddi, Gajjan Singh, Makhan Singh and their family members apart from some associates were searched, the Enforcement Directorate (ED) said in a statement.

The money laundering case, filed under the Prevention of Money Laundering Act (PMLA), stems from multiple Punjab Police FIRs filed against Makhan Singh's son Hardev Singh alias Rambo and others under various sections of the Narcotic Drugs and Psychotropic Substances Act (NDPS) and the Arms Act.

Hardev Singh, the agency said, is currently lodged in Amritsar central jail in a 2018 drugs case related to recovery of 4 kg heroin.

Two rifles, three pistols and some bullets were recovered during the searches, it said. **PTI**

Aman Arora kick starts 'Khedan Halqa Sunam Diyan'

"I owe it to them and will continue to serve them, as always. I derive my strength from my people. Everything else is secondary," Kaur said on Twitter on Saturday.

The Congress' disciplinary panel mem-



ber secretary Tariq Anwar had said the action follows complaints against her from the party's Punjab unit chief Amarinder Raja Warring and other state leaders that

she was helping the BJP in the state. "The Congress president has received a complaint from Amarinder Singh Raja

a complaint from Amarinder Singh Raja Warring, president of PCC Punjab, that Preneet Kaur, MP (Lok Sabha) from Patiala is indulging in anti-party activities to help BJP.

"Some other senior Congress leaders of Punjab also share this view," Anwar had said in a statement.

It was not the first time that Kaur was served a show-cause notice by the party.

In November 2021, the Congress issued her a show-cause notice seeking an explanation for her alleged "antiparty activities". Kaur had then said that she did not receive any such notice, but had only read about it in newspapers and on social media.

In May last year, Punjab Congress chief Warring had also said that Kaur was not with the party anymore.

In the 2022 state assembly polls, Kaur even campaigned for her husband Amarinder Singh who contested the elections as an ally of the BJP.Kaur had been an MP in 1999, 2004 and 2009. She lost the Patiala Lok Sabha seat in 2014 but won it back in 2019. **PTI**

SGPC opposes any move to introduce helmets for Sikh soldiers

Soldier injured in landmine blast near LoC in Poonch

n army jawan was injured in a landmine explosion near the Line of Control (LoC) in Jammu and Kashmir's Poonch district on Saturday, officials said.

The landmine went off when a group of soldiers were patrolling a forward area in the Kerni sector in the morning, they said.

The injured soldier, Lance Naik Anshul Rawat, was immediately given medical aid and was later airlifted to the Command Hospital in Udhampur for specialised treatment, the officials said.

As part of an anti-infiltration obstacle system, forward areas are dotted with landmines which sometimes get washed away by rains resulting in such types of accidents, they said. PTI

Anti-encroachment drive intensified in Kashmir

he Jammu and Kashmir administration's anti-encroachment drive intensified on Saturday as the land illegally occupied by "influential persons" was retrieved at many places in the Valley, officials said.

Encroachments were removed from many places in Srinagar including at Humhama, Peerbagh, Padshahibagh, Nishat and Chattabal.

At Humhama, one kanal of state land was freed from the occupation of former director (information) Farooq Renzu Shah. Shah said the ancestral property belongs to his family and was not registered in his name.

In Srinagar's Kral Sangri Nishat area. the authorities demolished the outer wall and gate of the residential house belonging to advocate Shabnum Lone, who is the sister of Peoples Conference president Sajad Lone.

In Chattabal area of the city, the authorities sealed a shopping complex claiming it was built on state land.

However, advocate Shoaib Zahoor, owners of the property, said the particular chunk of land was allotted to them by the Srinagar Municipal Corporation (SMC) through an open auction in 2004.

"We are not encroachers. The J-K High Court gave me possession completely in 2012. In 2018, the High Court upheld the allotment as legal and valid. I got the commercial building permission from the competent authority (SMC) in 2019," Zahoor said. He said they were not served any notice for the sealing of the building. He appealed to the LG administration to look into the issue.

"Only influential and powerful people who misused their position and violated the law to encroach upon the state land would face the law of the land," Sinha said.

ating from state/ Kahcharai lands. The land lies at a short distance from NH44 Srinagar-Jammu National Highway and is valued in excess of Rs 20 crore.

The officials said the crushers have been given a week to remove the machinery from the spot failing which the machinery will also be seized.

Demolition drives were also undertaken in Bumthan Mirbazar and 14 kanals of land was retrieved from a stone crusher operating on state land.

The officials said such drives, especially against influential persons, will continue.

Democratic Azad Party (DAP) chief Ghulam Nabi Azad, meanwhile, demanded a formal order from the Raj Bhavan to spare the poor in the ongoing anti-encroachment drive. His party members took out a protest march from the party office at Sonwar and blocked the main road near Sonwar Chowk.

The Resistance Front (TRF), a shadow outfit of the banned Lashkar-e-Taiba (LeT), made an attempt to wade into the controversy, a move described by police as an attempt to misinform the general public.

"Harassing and dismantling properties of local Kashmiris in the name of New Colonial Land Laws', is just paving ways for illegal settlements. The hidden agendas behind these draconian diktats is to pave ways for non-locals not only to take local business, but also clear ways for settling these non-locals of particular mentality in Kashmir," the outfit said in a press release. PTI

'Will talk with Adani group to end cement impasse'

The Himachal Pradesh government is all set to end the impasse created by the closure of two cement factories and indefinite strike by truck operators union and the industries minister will hold talks with the Adani group to resolve the issue, Chief Minister Sukhvinder Singh Sukhu said on Saturday.

Talking to reporters at the NIT helipad here, Sukhu, who is on a three days tour of his home district Hamirpur, said the transporters' union representing truckers engaged by the two Adani group-owned cement plants in Bilaspur and Solan districts have proposed their rates and concerned officers have been directed to fix a meeting with the factory management.

Two cement plants at Barmana (Bilaspur district) and Darlaghat (Solan

district) owned by ACC Limited and Ambuja Cements, respectively, have been closed since December 14 due to a dispute over freight charges.

Taking a dig at BJP leaders, especially former chief minister Jai Ram Thakur on the issue of granting old pension scheme to the state government employees, Sukhu said this scheme had been implemented in toto and there was no question of ignoring it as it was one of the main election planks of the party.

Talking about the suspension of the Himachal Pradesh Staff Selection Commission following a paper leak, he said many more cases of paper leaks would come to the fore in the next few days.

He said the Hamirpur-based staff selection commission was the guardian of corruption and his government would not allow graft to survive in the state. **PTI**



Ahead of 2024 polls, BJP to strengthen position in 'weak booths'

In the meeting, which lasted for about four hours, a strategy to corner the Congress government was also discussed. Reasons for the BJP's defeat in the assembly elections in November were also reviewed.

The BJP is a disciplined political party and will not tolerate indiscipline. Strict action is being taken against those who worked against the party in the assembly polls, said state unit chief Kashyap. **PTI**

Let the parliament function

ost of the budget session of the parliament is again at risk of getting Lwasted. The opposition has made it a point to disrupt the Parliament and not allow its functioning till the government does not concede its demand. First the opposition parties wanted to discuss the issue of the Hindenburg report on the Adani companies. When the government agreed to discussion, the opposition has now come out with a demand for the Joint Parliamentary Committee probe into the entire saga. The opposition has every right to seek and demand the parliamentary probe into the report that has caused a devastating crash in the Adani business empire, but for that it really does not need to disrupt the Parliament.

It is the sad part of Indian parliamentary democracy that disruptions, instead of debates and discussions, have become the routine. The opposition parties have to compulsively find one issue or the other to corner the government. That is fair enough and in fact is the duty of the opposition parties. A healthy democracy needs a strong and powerful opposition. But that does not mean the parliamentary functioning needs to be disrupted and debate not allowed. If the government has agreed to debate on the Adani issue, the opposition should gracefully accept it and raise the issue in the Parliament through informed debate.

Adani group is a privately run business conglomerate. If it has done anything wrong let the law take its own course. But that is not the purpose of the opposition. It wants to embarrass the government given the fact that Adani is perceived to be very close to the powers that be. That, in fact, should not be held against anyone, neither the government nor Adani. If he has really done anything wrong, he will eventually be held accountable in the courts of law. Moreover, his empire has suffered huge losses, to the tune of Rs eight lakh crores, already. He has been repeatedly denying the allegations. Just because he was perceived to be, or was actually, close to someone in power should not be the reason for the opposition to get him crucified in a summary trial. After all, there is a due process of law, which mandates it to be followed.

If the opposition has a strong case against the government, it should not fight shy of presenting it inside the Parliament. Unfortunately in today's 24x7 media reportage, some of the parliamentarians feel that they will be better and much noticed outside the parliament than inside, where you are supposed to speak, debate and discuss which requires in depth knowledge and insight into issues. Moreover, inside the Parliament you cannot make wild and baseless allegations, which make great headlines, while there is no such limitation outside the Parliament. The Parliament house will always be a better place than Vijay Chowk, to seek and attract the attention of the entire nation. Our parliamentarians must understand and realize that, "parliamentary" behaviour is supposed to be exemplary.

Low annual limit for H-1B petitions affecting US employers

The low annual limit of 85,000 registrations for H-1B petitions is the main problem facing US employers trying to secure foreign talent, according to a new report about the skilled workers' visas, the most sought-after by Indian IT professionals.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

The report titled "H1B Petitions And Denial Rates In FY 2022' by National Foundation for American Policy (NFAP), a nonpartisan research organisation, said the low annual limit on H-1B petitions resulted in the vast majority of H-1B registrations not being selected. H-1B denial rates have returned to low levels following the Trump administration's losses in federal court during Donald Trump's last year in office, meaning the low annual limit for H-1B petitions is currently the main problem facing employers trying to secure foreign-born talent, it said.

The H-1B visa allocations are capped at 85,000 visas per year, with 20,000 of those set aside for workers holding advanced degrees from US institutions. The remaining 65,000 visas are awarded through a lottery system, making the competition for H-1B visas fierce.

In April 2022, US Citizenship and Immigration Services (USCIS) reported employers submitted over 483,000 H-1B registrations, almost 400,000 more than the 85,000-annual limit for H-1B petitions. H-1B visas allow skilled foreign workers to work and live in the US for up to six years in specialised fields such as technology, engineering, and medicine. After six years, it opens up pathways to permanent residency or Green Card.

H-1B temporary visas are important because they generally represent the only practical way for a high-skilled foreign national, including an international student, to work long-term in the United States and have an opportunity to become an employment-based immigrant and a US citizen, the NFAP said in a statement on Thursday. At US universities, more than 70 per cent of full-time graduates in electrical engineering and computer and information sciences are international students, it said.

"Despite the end of the Trump administration's restrictive immigration policies that made US companies less competitive in the global battle for talent, companies in America still must deal with the low annual limit on H-1B petitions and employment-based green cards," said Stuart Anderson, NFAP's executive director.

"These and other policies encourage employers to send work and people outside the United States and make it difficult for many talented people to pursue their dreams in America." A 2022 NFAP

study found 55 per cent of America's startup companies valued at USD 1 billion or more have at least one immigrant founder, illustrating the importance and contributions of immigrants to the US economy, it said.

The denial rate for new H-1B petitions for initial employment in FY 2022 was 2 per cent. The H-1B denial rate declined during the final year of the Trump administration after judges declared many of its H-1B-related actions unlawful, it said.

That forced a legal settlement and changes to restrictive immigration policies that resulted in the denial rate for new H-1B petitions for initial employment in FY 2021 dropping to 4 per cent, far lower than the denial rate of 24 per cent in FY 2018, 21 per cent in FY 2019 and 13 per cent in FY 2020.During the Trump administration, the denial rate for H-1B petitions for initial employment was much higher at 13 per cent in FY 2017, 24 per cent in FY 2018, 21 per cent in FY 2019 and 13 per cent in FY 2020.

Amazon had the most approved H-1B petitions for initial employment in FY 2022, at 6,396. Amazon also had the most new H-1B petitions approved in FY 2021 and FY 2020. Infosys had the second most H-1B petitions in FY 2022 approved for initial employment at 3,151, which was approximately 2,000 fewer for the company than FY 2021.

Next was TCS with 2,725, also lower than the previous year, followed by Cognizant (2,521), Google (1,562), Meta/Facebook (1,546), HCL America (1,260) and IBM (1,239). H-1B petitions are counted in the fiscal year they are approved, not in the cap year the H-1B visa holder begins to work.

According to USCIS data, the median annual salary for H-1B visa holders was USD 108,000 in FY 2021. In computer-related occupations in FY 2021, the median salary for H-1B visa holders was USD 111,000, and the average salary in computerrelated occupations was USD 118,000, the report said. Despite high-profile layoffs in the technology industry, the 85,000-annual limit on H-1B petitions (for FY 2024) will likely be filled when the registration period opens in March 2023. That is because the annual limit is low relative to the size of the US labour force and the demand for talent, the report said.

The 85,000 new H-1B petitions allowed each year for companies represent only 0.05 per cent of the approximately 165 million people in the US labour force. Beginning in FY 2004, the supply of H-1B petitions has been exhausted every fiscal year up to the present. Analysts and technology watchers note that layoffs at tech firms need to be kept in perspective. "Even with all of the layoffs announced in recent weeks, most tech companies are still vastly larger than they were three years ago," reports Fortune.

Large and small tech companies went on a hiring spree over the past several years due to a surge in demand for their products, software and services with millions of people working remotely, the magazine explained.

Still, the layoffs have been difficult for US workers and H-1B visa holders, who often need to find another employer within 60 days to remain in H-1B status. About 79 per cent of workers recently hired after a tech-company layoff or termination landed their new job within three months of starting their search, according to a ZipRecruiter survey of new hires.

That was just below the 83 per cent share of all laid-off workers who were re-employed in the same time frame. Nearly four in 10 previously laid-off tech workers found jobs less than a month after they began searching, ZipRecruiter found in the survey.

"Despite the widespread layoffs, hiring freezes, and cost-cutting taking place in tech, many tech workers are finding reemployment remarkably quickly," said Julia Pollak, chief economist at ZipRecruiter. This NFAP analysis is based on data from the USCIS H-1B Employer Data Hub. **PTI**



'Opposition not given even a minute to raise Adani issue in Parliament'

Cong hits back at Thakur

he Opposition has not been given even a minute to raise the Adani issue in Parliament, the Congress said on Saturday, hitting back at Union Minister Anurag Thakur who said the government has nothing to hide on the matter.

Talking to reporters in Jammu, the information and broadcasting minister had accused the opposition parties of creating a ruckus in Parliament to evade a debate on the "people-friendly" budget.

Hitting back at him, Congress general secretary Jairam Ramesh tweeted, "I&B Minister, Anurag Thakur of 'Goli Maro' infamy says Opposition running away from debate in Parliament. What a joke. Parliament hasn't functioned for two days as the Opposition isn't even allowed to take a minute to demand JPC on the PM-linked Adani 'Maha mega



scam'." The Opposition has alleged that the recent meltdown in Adani Group shares is a scam that involves common people's money as public sector LIC and SBI have invested in them. The Opposition has demanded a joint parliamentary committee probe or a Supreme Court-monitored investigation into the Adani issue after allegations of financial irregularities and share price manipulation were levelled by the US-based short-seller Hindenburg Research. The Adani Group has dismissed the charges as lies, saying it complies with all laws and disclosure requirements. Union Minister Thakur said, "SBI, LIC, Finance Minister, RBI have made their statements on the Adani issue and have made things clear. The Opposition is running away from the discussion and does not want to discuss the President's address and the budget."

"We want discussion on the President's address and 2023-24 budget which will guide India from 'Amrit Kaal to Swarnim Kaal' and will lay the foundation of New India but the Opposition is running away from discussion," he told reporters at the BJP headquarters in Jammu. **PTI**



CJI hails Rs 7,000 crore budgetary allocation to e-courts project NEW DELHI, FEBRUARY 4

The proposed allocation of Rs 7,000 crore in the 2023-24 budget for phase three of the eCourts Project will enhance judicial institutions and efficiency while ensuring courts reach every citizen, Chief Justice D Y Chandrachud said Saturday.

Addressing the 73rd anniversary of the establishment of the Supreme Court, he said that during the COVID-19 pandemic period, the top court adopted video conferencing of court proceedings to reach out to the people.

"In the recent budget, the Government of India has introduced a provision of Rs 7,000 crore for phase-3 of the e-courts project. This will help enhance the accessibility of judicial institutions and the efficiency of judicial systems in India. Such endeavour will ensure the court reaches every citizen of India," Justice Chandrachud said.

Between March 23, 2020, and October 30, 2022, the apex court heard 3.37 lakh cases through video conferencing, he said. **PTI**

ISRO-NASA built satellite ready to be shipped to India for launch

n earth-observation satellite jointly developed by NASA and ISRO that will help study Earth's land and ice surfaces in greater detail is all set to be shipped to India later this month for a possible launch in September.

ISRO Chairman S Somanath visited NASA's Jet Propulsion Laboratory (JPL) in the US state of California on Friday to oversee the final electrical testing of the NASA-ISRO Synthetic Aperture Radar (NISAR) satellite before being shipped to India.

"This mission will be a powerful demonstration of the capability of radar as a science tool and help us study Earth's dynamic land and ice surfaces in greater detail than ever before," Somanath said at the formal send-off ceremony organised at the JPL which was attended by senior scientists from the two space agencies.

Later this month, the SUV-size payload will be moved into a special cargo container for a 14,000-kilometer flight to the U R Rao Satellite Centre in Bengaluru.

ISRO and NASA joined hands in 2014 to build the 2,800 kg satellite. In March 2021, ISRO sent its S-Band SAR payload developed in India to NASA for integration with the L-Band payload built by JPL.

"This marks an important milestone in our shared journey to better understand planet Earth and our changing climate. NISAR will provide critical information on Earth's crust, ice sheets, and ecosystems," JPL Director Laurie Leshin said.



Somanath said that the NISAR spacecraft will be integrated into the satellite bus at the U R Rao Satellite Centre for launch within the next year.

"This is one of the most complex satellites. The elements that are built by JPL are excellent," Somanath said.

The event at JPL was marked by the ceremonial breaking of coconuts in front of a scale model of the satellite by NISAR project heads of NASA and ISRO Phil Barela and C V Shrikant respectively.

The JPL Director also presented the ISRO delegation with a jar of JPL lucky peanuts to be eaten during the launch of the satellite.

NISAR will gather radar data with a drum-shaped reflector antenna almost 12 meters in diameter. It will use a signal-processing technique called interferometric synthetic aperture radar, or InSAR, to observe changes in Earth's land and ice surfaces down to fractions of an inch.

The satellite will help researchers detect slow-moving variations of a land surface that can precede earthquakes, landslides, and volcanic eruptions.

Data about such movements could help communities prepare for natural hazards such as the Joshimath land subsidence.

Measurements of melting sea ice and ice sheets will improve understanding of the pace and impacts of climate change, including sea level rise.

Over the course of its three-year prime mission, the satellite will observe nearly the entire planet every 12 days, making observations day and night, in all weather conditions. **PTI**



Smriti Irani slams Congress for disrupting Parliament proceedings

KOLKATA, FEBRUARY 4

Joint Minister Smriti Irani on Saturday slammed the Congress for disrupting the proceedings in Parliament demanding an independent investigation into the allegations of fraud against billionaire Gautam Adani's companies that triggered an unprecedented stock crash.

She alleged it is a reflection of the animosity the party has towards President Droupadi Murmmu from the day she took office.

Parliament was adjourned for the second consecutive day on Friday without transacting any business after the Opposition stepped up its demand for an independent investigation into the allegations of fraud against billionaire Gautam Adani's companies that triggered an unprecedented stock crash.

Proceedings in both Lok Sabha and Rajya Sabha were disrupted as Opposition members raised slogans demanding a discussion and a JPC probe into the fraud-allegation-triggered rout.

"The government has repeatedly said they are open for any conversation, but why would it not begin (not allow) with a vote of thanks to the President's speech? That the Opposition has always taken a stand which is anti-President of India is known to every citizen of the country," the Union Women and Child Development minister said while addressing a press conference here.

She alleged that it had been the political mandate of the Congress party not to show respect to the President of India.

"That President Droupadi Murmu has given a speech which lays not only the foundation of the future of India but also exhibits our present potential, the issues that need to debate...and thanks to be given to the hon'ble president of India," she said.

"Why would the Congress party deny that respect to the President of India? But I am not surprised that they will deny respect to the President of India because that has been their political mandate from the day the hon'ble President took office," she said.

Reacting to Irani's allegations, the Leader of the Congress party in Lok Sabha, Adhir Ranjan Chowdhury, dubbed it baseless. **PTI**

Crackdown on child marriage till 2026 Assam elections: Sarma

GUWAHATI, FEBRUARY 4

ssam Chief Minister Himanta Biswa Sarma on Saturday asserted that the drive against child marriage, launched by the state police from the previous day, will continue till the next assembly elections in 2026.

More than 2,250 people have been arrested in the state till Saturday in the crackdown on child marriage, according to an official statement.

Altogether 2,258 people have been arrested so far based on 4,074 FIRs registered against child marriages across the state, it said.

At least 139 people have so far been apprehended in Biswanath, followed by 128 in Barpeta and 127 in Dhubri, the police statement said.

Mr Sarma said parents involved in the underage marriage are currently being let off with notice and not being arrested.



"Our drive will continue till 2026 when the next assembly elections will be due. We are hopeful that by then, there will be no case of child marriage in the state," the chief minister said.

In over 4,000 cases of child marriage, there were more than 8,000 accused. "If we leave the parents out, the number of accused, who will face arrests,

comes to around 3,500," he said. The CM said the deputy commission-

ers have been asked to "control the system

of kazis" (Muslim priests who conduct marriages) and create general awareness against the menace.

The state cabinet had recently decided that those having married girls below 14 years of age will be booked under the Protection of Children from Sexual Offences (POCSO) Act.

The council of ministers also took a decision that cases under the Prohibition of Child Marriage Act, 2006 will be registered against those who have married girls in the 14-18 years age group.

They will be arrested and the marriages will be declared illegal.

If the groom is below 14 years of age, he will be sent to a "reform house".

Assam has a high rate of maternal and infant mortality, with child marriage being the primary cause as an average of 31 per cent of marriages registered in the state are in the prohibited age group, according to reports of the National Family Health Survey. **PTI**

Delhi excise scam

BJP stages protest at AAP office; demands Kejriwal's resignation

NEW DELHI, FEBRUARY 4

Dehi BJP leaders and workers on Saturday staged a protest at the AAP office here demanding the resignation of Chief Minister Arvind Kejriwal after the Enforcement Directorate named him in a charge sheet in the excise scam case.

Leader of Opposition in Delhi Assembly, Ramvir Singh Bidhuri alleged the AAP government was "looting" the city that was first looted by invaders like Mohammed Ghori, Mahmood Ghazni and Taimur, the British and thereafter by Congress governments.

"The Enforcement Directorate has named Kejriwal in its charge sheet related to the liquor scam and he should resign from the post of chief minister of Delhi," state BJP president Virendra Sachdeva said.

No immediate reaction was available

from the Aam Aadmi Party (AAP) to the allegations.

Several BJP workers were detained by police while trying to cross a barricade erected near the AAP office at DDU Marg.

The BJP will keep on exposing the "corruption" of the Kejriwal government which is weakening Delhi like a "termite", Sachdeva said during the protest.

The ED has claimed in its supplementary charge sheet filed in the court that a part of the alleged Rs 100 crore "kickbacks" generated in the scrapped Delhi excise policy was used in the AAP's 2022 Goa assembly election campaign.

It has also claimed that a close aide of the Delhi chief minister arranged a video call through FaceTime (a video calling facility on iPhone) on his phone for one of the accused Sameer Mahandru. **PTI**

Thousands of orphans will get opportunity to study at DU free of cost: VC

NEW DELHI, FEBRUARY 4

Delhi University Vice Chancellor Yogesh Singh on Saturday stated that thousands of orphan children, including those who lost their parents to COVID-19, will get an opportunity to pursue higher education free of cost with the university's new initiative to reserve seats for them.

The vice chancellor said the university has been responsible for providing education to the students seeking higher education without any discrimination on any grounds.

The varsity recently decided to reserve seats in each of its undergraduate and postgraduate programmes for orphans under supernumerary quota from the next academic year.

Such students will also be exempted from payment of any kind of fees, he said.

The decision was taken in a meeting of the Executive Council on Friday.

Speaking to PTI, Vice Chancellor Singh said, "The initiative will help thousands of children every year. We are coming out of Covid. Many children lost their parents during the pandemic. The initiative will also help those students." In all colleges and departments of the university, one seat each will be reserved for orphan boys and girls in all classes at both undergraduate and postgraduate levels.



"The University of Delhi understands the importance of providing higher education to every section of society, including those students who have unfortunately lost their parents and become orphans," he said.

The expenditure incurred for the admission and continuation of studies of such students in the university or its colleges will be met from the University Welfare Fund or the College Students' Welfare Fund.

The vice chancellor said this initiative would be a positive step towards the achievement of 50 per cent gross enrolment ratio (GER) in higher education by the year 2035 as envisaged in the National Education Policy 2020 and would link the ongoing efforts with its Institutional Social Responsibility (ISR) in the centenary year of the university. **PTI**

G-20 Summit: Delhi govt seeks Rs 927 crore from Centre

peputy Chief Minister Manish Sisodia on Saturday wrote to Union Finance Minister Nirmala Sitharaman seeking funds for the Delhi government for the preparation of G-20 Summit.

In his letter, Sisodia said, "Hosting the G20 Summit is a matter of pride for Delhi." The Delhi Government needs Rs 927 crore for special preparations for G-20, he added. He pointed out that the Delhi government did not get any funds in the Union Budget. Hence the Central government should sanction additional funds for the preparations for the G-20. Sisodia assured that the Delhi government will provide full assistance to the Union government in the planning to make the G-20 summit a great success. He added, "In this regard, the various departments of the Delhi government have formulated an outline for events related to infrastructure development. Amongst these, there are proposals for the beautification of spots where G-20 events are set to take place, as well as proposals for the staging of specific events and functions." Sisodia said Lieutenant Governor VK Saxena is engaged in a continuous review of these preparations. "You would be aware that the Delhi Government has not received any financial support from the Central Government as its share from the central taxes. The Delhi Government also does not receive any extra grants from the Central Government," the deputy chief minister said in the letter.

He said, "In fact, the MCD does not receive the funds that other municipalities across the country receive on account of the population in their jurisdiction." **PTI**

Now, online CEE for Agniveer recruitment

The army has announced a change in the Agniveer recruitment process and candidates wanting to join the force will now have to first appear for an online common entrance examination (CEE), followed by physical fitness and medical tests.

The first online CEE is slated to be held in April at nearly 200 locations across the country and for it all prepara-



tions have been finalised, a source said.

"The changed methodology will ensure increased focus on cognitive aspect during selection. It will have wider outreach across the country and also reduce the large crowds seen during recruitment rallies to make them more manageable and easier to conduct," the source said. **PTI**

India, France, UAE unveil trilateral cooperation framework

ndia, France and the UAE on Saturday unveiled an ambitious roadmap for cooperation in areas of defence, nuclear energy and technology under a trilateral framework.

After a phone conversation among their foreign ministers, a joint statement said the three sides agreed that the trilateral initiative will serve as a forum to promote the design and execution of cooperation projects in the fields of energy, with a focus on solar and nuclear energy.

"It was acknowledged that defence is an area of close cooperation between the three countries. Therefore, efforts will be undertaken to further promote compatibility, and joint development and co-production, whilst seeking out avenues for further collaboration and training between the three countries' defence forces," it said.

The foreign ministers noted that the trilateral initiative will serve as a platform to expand cooperation between their



countries' development agencies on sustainable projects.

The three foreign ministers met on September 19 last year for the first time in a trilateral format on the margins of the United Nations General Assembly in New York.

In the meeting, they agreed to establish

a formal trilateral cooperation initiative to expand cooperation in various fields of mutual interest.

"It is in this context that a phone call between the three ministers was held today to adopt a roadmap for the implementation of this initiative," the statement said. **PTI**

US lawmakers hail reduction of tariff duty on pecan imports by India

group of influential lawmakers from Georgia on Friday celebrated the decision of the Indian government to reduce tariff of US pecan exports by 70 per cent.

It may bring down the cost of pecan, locally called nuts, in India significantly The move would benefit thousands of farmers and is a big deal for the American pecan industry, they said.

Senator Raphael Warnock said he is thrilled to see months of advocacy on behalf of Georgia pecan growers and sellers pay off.

"Georgia produces nearly a third of America's pecans, and this announcement from the Indian government is welcome news that will expand global access to Georgia, and further cement our state's status as a prime agriculture state," said the Senator who is a member of the Senate Agriculture committee. House Agriculture Committee Vice Chair Austin Scott, Ranking Member of the House Agriculture Committee David Scott, and Ranking Member of the House Appropriations Subcommittee on Agriculture, Rural Development, Food and Drug Administration, and Related Agencies, Sanford D. Bishop, Jr. in a joint statement applauded the decision of India's government to reduce tariffs on US pecan exports by 70 per cent.

The decision reflects over a decade of bipartisan, collaborative efforts on behalf of America's pecan growers, they said. Georgia is the top pecan producing state in the US and the local industry is valued at USD 250 million.

"The announcement that India will lower the tariffs on US pecans by 70 per cent is a big deal for Georgia pecan growers and the American Pecan Industry," Bishop said.

"Much of the global supply of pecans is grown right here in Georgia, and I commend India's decision to reduce tariffs on our pecan exports and allow us into their growing market," said Scott. "This is more than a win for pecan farmers, this is a win for Georgia, and it couldn't have been done without the hard work of my colleagues Representatives Sanford Bishop and David Scott," he said.

Congressman Scott thanked the US Trade Representative and the US Department of Agriculture for the years of hard work that led to this outcome. **PTI**

Traffickers charge Indian \$21k to enter US illegally

riminal transnational organisations called cartels on an average charge USD 21,000 from Indians to help them illegally cross over the American border, an Arizona Sheriff has told lawmakers here.

The minimum being charged by a cartel for a foreign national to illegally come into the United States is USD 7,000, Sheriff Mark Dannels of Cochise County, Arizona, told members of the House Judiciary Committee here this week. Informing the lawmakers that the border along Mexico is not secure, Dannels said criminal transnational organisations called cartels control the south of the US border.

"South of it's all controlled. They control who comes across. There's prices based on who you are. You're a terrorist coming from a different country," he said.

"I think India was USD 21,000, for example. But the minimum is, like, around USD 7,000 right now. Most of these people don't have it," he said in response to a question from Congressman Barry Moore. **PTI**

First task to get Chinese balloon out of US airspace: Blinken

Cancels China visit

WASHINGTON, FEBRUARY 4

S Secretary of State Tony Blinken on Friday said the first task at their disposal is to ensure that the Chinese surveillance balloon which is hovering over its sky is out of its territory, as he defended his decision to postpone his planned trip to Beijing.

"Job one is getting it out of our airspace. We continue to believe that having open lines of communication is important. Indeed, this incident only underscores the importance, and that's why we will maintain them. That's why, when conditions permit, I plan to go to China. But the most important thing right now is to see that this surveillance asset gets out of our airspace, and we'll take it from there," Blinken told reporters at a news conference here.

At the joint news conference with the visiting South Korean Foreign Minister Park Jin, Blinken said it was very important to emphasize that the presence of this surveillance balloon over the United States skies was a clear violation of its sovereignty, international law, and clearly unacceptable.

"We have made that clear to China.



Any country that has its airspace violated in this way I think would respond similarly. And I can only imagine what the reaction would be in China if they were on the other end," he said.

"What this has done is created the conditions that undermine the purpose of the trip, including ongoing efforts to build a floor under the relationship and to address a broad range of issues that are of concern to the American people, I believe to the Chinese people, and certainly as well to people around the world," Blinken said. "China's decision to fly a surveillance balloon over the continental United States is both unacceptable and irresponsible. That's what this is about.

It's a violation of our sovereignty, it's a violation of international law. And it was very important that we of course take the actions we did to protect any sensitive information, to protect our people, and to make clear to China that again this is an unacceptable as well as irresponsible action," he said in response to another question."It's even more irresponsible coming on the eve of a long planned visit that followed from the meeting between the two presidents in Bali on the margins of the G-20. In our judgment, it created conditions that undermined the very purpose of the trip, including ongoing efforts, as I said, to build a floor under the relationship as well as to address a very broad range of issues that are important to Americans, to Chinese, to the entire world," he said.

Blinken said the world expects the United States and China to manage their relationship responsibly. "And indeed, addressing many of today's global challenges, challenges that affect the lives of our people and people around the world, demands that we find a way to work together as well. The United States will continue to act in a way that reflects that responsibility," he said. **PTI**



Pakistan blocks Wikipedia over 'blasphemous' content

ISLAMABAD, FEBRUARY 4

Pakistan has blocked Wikipedia, the online encyclopedia, for its failure to remove offensive or blasphemous material, the country's telecommunications authority said on Saturday.

The blacklisting of Wikipedia comes days after the Pakistan Telecom Authority (PTA) degraded Wikipedia services for 48 hours, threatening to block it if the content deemed 'blasphemous' was not deleted.

Wikipedia is a free online encyclopedia, created and edited by volunteers around the world and hosted by the Wikimedia Foundation.

PTA spokesperson Malahat Obaid said the ban had primarily been imposed for non-compliance with the orders. **PTI**

A ctor Benedict Cumberbatch is set to headline Netflix's upcoming series "Eric" and will also serve as executive producer on the show.



Adani FPO fallout not affected India's image: Sitharaman

MUMBAI, FEBRUARY 4

ndia's economic image is not affected due to Adani Group's recent decision to pull out Rs 20,000 crore FPO amid allegations of financial wrongdoings, Finance Minister Nirmala Sitharaman said on Saturday. The finance minister said there has been an accretion of USD 8 billion to the forex reserves in the last two days alone. "...our macroeconomic fundamentals or our economy's image, none of which has been affected. Yes, FPOs (follow-on public offers) come in, and FIIs (foreign institutional investors) get out," Sitharaman told reporters here. The minister said there are "fluctuations" in every market but the accretion over the last few days establishes the fact that the perception of both India and its inherent strengths is intact.

Answering a broader question on the allegations against Adani Group, she said the country's independent financial sector regulators will be looking into the aspect and added that capital markets watchdog Securities and Exchange Board of India has the wherewithal to ensure stability in markets.

"...for keeping the market and the markets regulated in prime condition, the

Sebi is the authority. And it has the wherewithal to keep that prime condition," she said. The finance minister also said that the RBI has already spoken out on the issue, referring to Friday's statement, which said the banking sector is resilient and stable.

About ten days ago, US-based short seller Hindenberg Research made a slew of allegations on the corporate governance front against Adani Group. The Ahmedabad-based group has denied all the allegations and termed it as a calculated attack on India. It has cancelled the FPO even after managing subscriptions to it. Finance Secretary TV Somanathan on Saturday stood by his comment on the controversy where he called it a storm in a teacup, clarifying that this is in the context of macroeconomic terms and the stability of India's public financial institutions. Meanwhile, on the decision to convert outstanding dues into equity at Vodafone Idea, Somanathan said the transaction is being done as a package for all telcos. He said the government share will be held by the Department of Investment and Public Asset Management (DIPAM) where the stake will be considered as a public shareholder. DIPAM secretary Tuhin Kanta Pandey said the



price has been taken at Rs 10 despite the Vodafone Idea shares trading lower on bourses because, as per laws, preferential allotments have to happen at the face value of a share. The finance ministry officials present at the meet also made it clear that the tweaks on taxation in the insurance front will not impact the policy agenda of deepening penetration and clarified that there was sufficient data to suggest that investments were masquerading as insurance premiums due to which a decision was taken to tax the same. Sitharaman said there is no timeline which has been decided to end the old tax regime, and the government has only introduced a simpler new tax regime, which has the incentives of lower rates. The officials also denied that this will impact the savings in the economy. Chief Economic Advisor V Anantha Nageswaran said citizens are being given an expanded array of choices to determine what they want to do with their money. Answering a question on introducing the controversial p-notes for GIFT City, Somanathan said it competes with other international financial services centres due to which such provision has to be made and added that India always retains the right to mitigate any perceived risks. Somanathan said the Rs 35,000 crore outlay for green initiatives will be primarily used for retrofitting in petroleum refineries and augmenting strategic storage capacity. "Some of the public sector refineries and other infrastructure facilities in the petroleum sector need retrofitting to meet our ambitious emissions and pollution targets," he said. PTI

SEBI 'assures' market integrity in wake of Adani crisis

mid a raging controversy over a meltdown in Adani group stocks, regulator Sebi on Saturday said it is committed to ensuring the stock market's integrity and all necessary surveillance measures are in place to address any excessive volatility in individual shares.

Without naming the Adani group specifically, the capital markets watchdog said in a statement that unusual price movement in the stocks of a business conglomerate has been observed in the past week.

Officials confirmed that the statement has been issued in the wake of the Adani matter only.

"As part of its mandate, Sebi seeks to maintain orderly and efficient functioning of the market and has put in place a set of well-defined, publicly available surveillance measures (including the ASM framework) to address excessive volatility in specific stocks.

"This mechanism gets automatically triggered under certain conditions of price volatility in any stock," the Securities and Exchange Board of India (Sebi) said.

Stock exchanges BSE and NSE have



put three Adani group companies -- Adani Enterprises, Adani Ports and Special Economic Zone and Ambuja Cements -- under their short-term additional surveillance measure (ASM), which basically means that intra-day trading would require a 100 per cent upfront margin and is aimed at curbing speculation and shortselling in these stocks.

Sebi further said that in all specific entity-related matters, if any information comes to its notice, then, as per extant policies, the same is examined and after due examination, appropriate action is taken.

"Sebi has consistently followed this approach on entity-level issues and would continue to do so in future as well," it added. **PTI**

FCI wheat e-auction on Feb 15

NEW DELHI, FEBRUARY 4

The next e-auction for the sale of FCI wheat to bulk consumers like flour millers under the open market sale scheme (OMSS) will be held on February 15, the Food Ministry said on Saturday.

State-run Food Corporation of India (FCI) has been mandated to sell 25 lakh tonnes of wheat from its buffer stock to bulk consumers under the OMSS in order to contain rising prices of wheat and wheat products in the country.

The first sale of wheat through e-auction was held on February 1-2. About 9.2 lakh tonnes of wheat was sold from FCI depots in 23 states. The plan was to hold a weekly e-auction every Wednesday.

However in a statement, the Food Ministry said: "The second sale of wheat through e-auction will be held throughout the country on 15th February on Wednesday." This means the FCI will not hold e-auction of wheat next week and the ministry has not cited reasons for not holding the auction.

Meanwhile, the FCI has directed all winning bidders of the first e-auction to remit the cost and lift the stock immediately from concerned depots across the country and make the same available in respective markets in order to further contain the prices.

"The prices are set to fall further after the wheat sold in the e-auction is lifted



and atta is made available in the market," it added.

Wheat is being offered at a reserve price of Rs 2,350 per quintal plus freight charges.

Last month, the government announced plans to sell 30 lakh tonnes of wheat in the open market from its buffer stock under OMSS in order to check wheat and wheat flour prices.

Out of 30 lakh tonnes, FCI will sell 25 lakh tonnes to bulk consumers like flour millers through e-auction and 2 lakh tonnes to states/Union Territories.

About 3 lakh tonnes wheat will also be given to state-PSUs, cooperatives and Federations like Kendriya Bhandar, NCCF and NAFED at concessional rate of Rs 2,350 per quintal without e-auction for converting wheat into wheat flour and offer it to public at a Maximum Retail Price of Rs 29.50 per kilogram.

Under the OMSS policy, the government allows FCI to sell foodgrains, especially wheat and rice, at predetermined prices in the open market from time to time to bulk consumers and private traders. The purpose is to boost the supply during the lean season and moderate the general open market prices.

The Centre had banned wheat exports in May last year to control rising prices, after a slight fall in domestic production and a sharp decline in the FCI's procurement for the central pool.

India's wheat production fell to 106.84 million tonnes in the 2021-22 crop year (July-June) from 109.59 million tonnes in the previous year due to heat waves in a few growing states. **PTI**

Took provisional suspension for swift resolution of doping case: Dipa

NEW DELHI, FEBRUARY 4

Anded a 21-month ban for failing a dope test, Indian gymnastics ace Dipa Karmakar on Saturday said she accepted provisional suspension after returning positive for a banned drug to swiftly resolve her case with the international federation.

Karmakar, however, claimed that she "unknowingly ingested" the prohibited substance Higenamine -- S3 Beta-2 Agonists as per WADA prohibited list -- which was found in her done sample.

"I unknowingly ingested and could not determine the source of (the banned substance). I decided to take a provisional suspension with the hope of a swift resolution with the international federation," Karmakar wrote on her Twitter handle, indicating that she had admitted to the doping rule violation.

Karmakar's dope sample was collected out-of-competition by the International Testing Agency (ITA), an independent organisation that manages the anti-doping programme of the International Gymnastics Federation (FIG), on October 11, 2021.

According to the US Anti-Doping Agency, Higenamine is found in several herbs used for traditional medicine and is used in supplements without sometimes naming it. It was added to the WADA prohibited list in 2017. The drug is prohibited at all times, both in and out-ofcompetition. The 29-year-old Karmakar, who shot to fame after finishing fourth



in the 2016 Rio Olympics in the vault event, has been struggling with injuries ever since she underwent a surgery to treat an anterior cruciate ligament (ACL) injury in 2017. Her last FIG event was the 2019 World Cup in Baku.

Her ban period will, however, end on July 10 this year as it was counted from the day (October 11, 2021) the sample was collected. Her results have been disqualified from October 11, 2021 onwards.

Karmakar said mentally her doping case has been the "toughest" battle she has fought in her life.

"I didn't even know how it (the banned drug) entered my body and that for any sports person...it would have broken anybody. So it is not only hurtful but also the toughest mental battle that I have ever fought," the gymnast from Tripura told PTI. "I had two surgeries in 2017 and 2019 and when I returned to the field... I mean, I faced one setback after another. I just want to get back on the field." **PTI**

Nagal brings India back into Davis Cup

HILLEROD (DENMARK), FEBRUARY 4



Once masters of spin, India wary of turning pitches

Fully aware of the current Indian batting line-up's issues of tackling spinners on rank turners, the team management will do well to ask for sporting tracks against Australia in the upcoming four-match Test series, one which offers turn from third day, feel former selectors and experts.

Once known as master players of spin, the Indian teams in recent years have looked more at home against express pace and steep bounce while struggling against slow bowling.

The only noteworthy innings in the last two to three years on a rank turner would be current skipper Rohit Sharma's technically perfect knock of 161 on a wretched Chepauk track where the other top order batters had struggled.

"Playing spinners on a flat deck isn't the problem. We must admit that our batters have struggled against quality spin bowling on tracks that have offered turn. I don't know what kind of tracks will be in the offing but rank turners could backfire," former Test spinner and noted commentator Murali Kartik told PTI during an interaction.

He also felt that India won't prepare "snake pits" but he would expect the tracks to offer turn from second day onwards. "I have full confidence in Rohit, Cheteshwar Pujara and Virat (Kohli) that they would handle Nathan Lyon admirably," Paranjape said.His former colleague Devang Gandhi concurred on the choice of Axar as the third spinner. "Look, if you have a track that starts breaking right away, then Axar is a better choice than Kuldeep. Kuldeep will release the ball from the back of his hand and hence flight more," said Gandhi. Former chairman of selectors MSK Prasad feels that Shubman Gill's new found confidence should be used to fullest effect and he should bat in the opening slot and not go down the order.


India more vulnerable at home this time: Chappell

Batting great Greg Chappell believes Australia can win the upcoming high-profile fourmatch Test series as India are "vulnerable" this time with injuries to key players like Rishabh Pant and Jasprit Bumrah.

While the swashbuckling keeperbatter Pant is ruled out for most part of the year as he continues to recover from injuries sustained during a horrific car crash, Indian pace ace Bumrah (back injury) does not figure in the Indian squad for the first two Tests.

"Australia can win this series. India are more vulnerable at home than they have been for some time due to injuries to key players like Rishabh Pant, Ravindra Jadeja and Jasprit Bumrah. They will rely heavily on Virat Kohli," Chappell wrote in an opinion piece for



'Sydney Morning Herald'.

"Visiting teams are often fooled by a game that seems to be going nowhere but suddenly changes at a frenetic pace. The Indians are used to this, so Australia will need to adapt quickly with mind, bat and ball," said the former India coach. **PTI**
